TOURNAMENT RULES

1. Prize money will be paid half for actual and half for handicap. You can cash in only one division. In case of a tie, the actual pin fall will take preference. The handicap will be 85% of 220 scratch. The prize fund will be returned 100% in prizes. \$200.00 from our 700 Club's treasury will be added to the prize fund.
2. You will bowl 6 games across 12 lanes. Lane assignments will be drawn in advance.
3. Entering average: Everyone will use their highest sanctioned yearbook average from the 2008-2009 season from any sanctioned league of 21 games or more. If you have no average from last year, then you will use your highest sanctioned average as of January 1, 2010 of 21 games or more. Bowlers with neither of the above averages must bowl scratch.
4. **If the current season average as of January, 1 2010 exceeds last season's average by 10 or more pins, current season average must be used (USBC Rule 319a, item 2). If the submitted average is lower than required, the bowler's score will be disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average (USBC Rule 319a, Item 3). Bowlers with an incorrect average will remain eligible for actual division prizes.**
5. **USBC Rule 319d (prize money won over \$600) and rule #319e (Avg. adjustment) are in effect for all bowlers in this tournament.** Failure to use the adjusted average is cause for forfeiture of entry fees and prize winnings.
6. Open only to members of the Ann Arbor Association 700 Club who are paid up in dues for the 2009-2010 bowling season. Those who are not yet USBC members may buy an affiliate membership card (\$19.00) or pay a \$5.00 participation fee.
7. Ten minutes of practice on your starting pair will begin at 10:00 a.m.
8. **No confirmations will be sent so be sure to write down the date so you remember!**
